1. Identification	Enviro-Tablets Toilet Tablets 60g
A. Common Uses	Aerobic bacteria water treatment for use in commercial, industrial, institutional and domestic water systems to remove fats/oils/greases, organic deposits, bad smells and improve water quality
2. Composition	A solid tablet blend of: Sodium Carbonate, binders, nutrients, Anionic Surfactants, , Non-Pathogenic Bacterial Strains, Food dye and fragrances.

3. Hazards Identification	Persons with known severe respiratory disorders should avoid inhalation of the powder. Could be harmful if swallowed.

Clean up Procedure: If dry, vacuum or dry sweep spilled material and place in closed plastic bags for disposal. If wet, place wet material in a drum or bucket lined with a plastic bag. The bag should not be tightly closed. Allow the bag to aerate for 24 hours before disposal. Disposal bag should be pin holed near the top to avoid bursting if carbon dioxide or oxygen gas is evolved. Wash spill site with water. If bacterial contamination is an issue use chlorine to kill the bacillus spores.
